BOOKING CONFIRMATION –

To book a birthday party, the client should complete and sign the provided Booking Form and return it, together with the reservation deposit (see below). This signed booking form acts as confirmation of your acceptance of these Terms and Conditions.

RESERVATION DEPOSIT –

A deposit of \$50 is required to secure the booking. A period of seven days will be provided to allow for this payment to be received, during which the booking will remain as 'provisional'. Please therefore ensure that this payment is made quickly to avoid potential loss of the requested dates (especially for peak periods).

A signed copy of the Booking Form must be received, along with this booking deposit.

The full amount must be paid the week before the party or on the day on arrival (only if club manager has agreed to it).

PAYMENTS –

Our preferred payment method is via direct bank transfer which normally incurs no costs for either party. If payment is made on arrival, it will be done via eftpos machine.

CANCELLATIONS –

Cancellation of the booking less than 48h, the deposit will not be refund.

Cancellation of the booking more than 48h, full deposit will be refund.
